OFFICIAL RULES

1. **ENTRY.** The promotion begins 10/01/08 and ends 12/12/08. In order to enter the drawing, a member refers a new member to Southwest Airlines Federal Credit Union (SWACU) using a Member Referral Form available at any SWACU branch or by visiting www.swacuflash.org. The referred member must return the form via mail or at any SWACU branch. Mailed entries must be received no later than 12/12/08. Members and non members within the field of membership may also enter without referral or obligation by printing their name and address on a 3" x 5" card and mailing it to: Southwest Airlines Federal Credit Union Member Referral Promotion, P.O. Box 35708, Dallas, TX 75235. Only one entry per envelope will be accepted. Southwest Airlines Federal Credit Union is not responsible for lost, late, stolen, misdirected, illegible, or postage-due entries. All entries become the property of SWACU and will not be acknowledged or returned. By submitting any entry, you agree to be bound by these Official Rules. Any violation of these Official Rules will result in disqualification.
2. **PRIZES.** Referring Member: For each qualifying referral, the referring member will receive one drawing entry. Three prizes will be awarded to a referring member: Grand Prize **42" flat screen TV** (up to \$1,200 value), Second Prize **Nintendo Wii bundle** (up to \$275 value), Third Prize **GPS Navigation** (up to \$200 value). New Member: Each new member will receive one drawing entry for a Grand Prize of **\$1,000**. The Grand Prize awarded will be in the form of a deposit to a SWACU regular savings account.
